PURPOSE OF THE TREATMENT

The processing of your data is carried out for associative needs and for the fulfilment of associative, legal, tax and insurance obligations.

PROCESSING METHODS

The data will be processed with the aid of electronic and / or computer tools and will be stored in computer media, on paper or on any other type of suitable support; everything will be done in full compliance with the minimum security measures in accordance with the technical regulations concerning minimum security measures, Annex B of the Privacy Code.

OBLIGATORY NATURE AND CONSEQUENCES OF DATA REFUSAL

SUBJECTS TO WHICH PERSONAL DATA MAY BE DISCLOSED

Personal data relating to the treatment in question may be communicated:

1. to the national-regional headquarters of our company Association
2. to other clubs and / or sports promotion bodies within our organisation

RIGHTS OF THE INTERESTED PARTY

In relation to the processing of personal data, the interested party has the right, pursuant to art. 7 (right of access of personal data and other rights) of the d. lgs. 196/2003:

1. to obtain confirmation of the existence or not of personal data concerning them, even if not yet registered, and their communication in intelligible form.
2. to obtain information:
 - a) on the origin of personal data; b) on the purposes and methods of their processing; c) on the logic applied in case of their treatment via electronic instruments; d) on identifying the details of the holder, of the responsible and of the designated representative according to article 5, paragraph 2; e) on the subjects or categories of subjects to whom the personal data may be communicated or who may become aware of them, as appointed representative in the territory of the state, of managers or agents.
3. to oversee: a) updating, rectification or, when interested, integration of data; b) the cancellation, transformation into anonymous form or blocking of data processed unlawfully, including data whose retention is unnecessary for the purposes for which the data were collected or subsequently processed; c) the attestation that the operations referred to in letters a) and b) have been brought to the attention, also as regards their content, of those to whom the data have been communicated or disseminated, except in the case where this fulfilment is it proves impossible or involves a use of means manifestly disproportionate to the protected right.
4. to object, in whole or in part: a) on legitimate grounds, to the processing of personal data concerning him / her, even though they are relevant to the purpose of the collection; b) to the processing of personal data concerning him for the purpose of sending advertising or direct sales material or for carrying out market research or commercial communication.
